News From Around PA

Erie Insurance is the main sponsor of the **27th Annual Erie Pride Picnic** at the Rotary Pavilion at Presque Isle on August 10th.

August 11th will be "Pride Day at **Waldameer**" in Erie.

As early as 2020, Pennsylvania will begin offering a **third gender option** on driver's licenses. At this point details are still be hashed out as to what would be required of residents who want to identify as X. A DOT spokesman said these are, "something that's been on our radar and people have been asking for."

The Democrat mayor of **Reading** has changed his mind and says he will allow the gay pride flag to fly over City Hall for the first time.

A vote was taken in the US House to table H Res 498, a bill calling for the **impeachment of President**

Trump. The vote to table the bill was 332 to 95. The 95 voting to proceed with impeachment were all Democrats, including PA US House members Brendan Boyle, Madeleine Dean, Michael Doyle, Dwight Evans, and Mary Scanlon.

News From National Scene

The ACLU is leading a petition drive in support of **two male athletes** in Connecticut who are dominating girls' track. Totally ignoring biology, they claim "inaccurate stereotypes" are causing the opposition to boys in girls sports.

Three transgender individuals are suing Alabama for its requirement that a person must undergo "**gender reassignment surgery**" in order to change the sex designation on their driver's license. The ACLU is saying states should not be forcing medical decisions!

New York Governor Andrew Cuomo has signed into law the "**Green Light Bill,**" which allows illegal aliens to apply for drivers' licenses. Rensselaer County Clerk Frank Merola (R) has followed

Erie County Clerk Mickey Kearns (D) in suing the state in an attempt to prevent the law from taking effect. Several more clerks and other local officials appear poised to take legal action as well.

Rep. Castro, the brother of Democratic presidential candidate Julian Castro who is pushing to **decriminalize illegal immigration**, introduced legislation to remove the terms "illegal" and "illegal alien" from immigration laws. His legislation would replace the terms with "foreign national" and "undocumented foreign national."
