**News From National Scene** The **11<sup>th</sup> Circuit Court of Appeals** has let stand the decision by a three-judge panel that struck down laws that banned talked therapy for gender-confused children and those with unwanted same-sex attraction.

Fifteen religious leaders, including pastors of the United Church of Christ and the Episcopal Church, three rabbis, a Buddhist lama, and a Unitarian Universalist minister, file a lawsuit to overturn **Florida's 15-week abortion ban** claiming it violates freedom of religion and speech.

**President Joe Biden** signed an executive order that directs HHS Secretary Xavier Becerra to "consider actions to advance access to reproductive health care services, including, to the extent permitted by [f]ederal law, through Medicaid for patients traveling across [s]tate lines for medical care."

Thirty million low-income students could go hungry if the **Biden Administration** withholds money for free and reduced meals. The threat is leveled at school districts that don't have an open bathroom/locker room policy for "transgender" kids.

After a five-year battle the **Christian flag** was finally raised over Boston! The US
