**News from Around PA**

The **U.S. Department of Education** will investigate a complaint filed by the ACLU of PA alleging a "toxic" environment for LGBTQ students in the Central Bucks School District.

A work around our elected legislators: **The Independent Regulatory Commission** voted 3-2 to approve changes proposed by the Pennsylvania Human Relations Commission to define "sex" in sex discrimination cases to offer protection to people who are discriminated against based on their gender identity of sexual orientation.

Fate of effort to put **Constitutional amendments** before voters mired in House power struggle and Governor Wolf's lawsuit. Proposed amendments include requiring a photo ID in order to vote and declaring there is no constitutional right to abortion.

Heirs of **Walmart founder Sam Walton's** fortune have funneled millions of dollars into pushing the LGBTQ agenda in their home state of Arkansas - sponsoring local drag shows, drag queen story hours for kids, and "teens only" events for those who identify as LGBTQ. Millions have also been pumped into public schools to promote "diversity, equity, and inclusion" – CRT buzz words!
