News From Around PA NOTE: In last week's enewsletter, it was stated that PA banned "Gender Queer: A Memoir" and "Lawn Boy." In actuality, PA is one of 43 states that has an exemption under the obscenity law --"Nothing in this section shall apply to any recognized historical society or museum accorded charitable status by the Federal Government, any county, city, borough, township or town library, any public library, any library of any school, college or university or any archive or library under the supervision and control of the Commonwealth or a political subdivision." Obviously, the law needs changed or enough outcry locally to get the obscene material removed!!

News From National Scene Some Critical Race Theory resources used in California: Race Conscious "Raising Children," "Anti-Racism for Beginners," "Social Identities and Systems of Oppression," "Black Lives Matter Resource Guide," "The Black Radical Tradition," "George Floyd, Racism. and Law Enforcement." One lesson asks the students to write a poem discussing a world without the police or the military. Another includes writing prompts on police brutality and racist violence. Is any of this in PA?

The student government at the **University of Oregon** is petitioning the school to require critical race theory training for graduation.

The Illinois State University is being sued by the former assistant football coach who was fired for removing a Black Lives Matter poster, which had been placed there during his leave of absence, from his office door and replacing it with an "All Lives Matter" sign.

Teachers in Virginia are encouraged to make students aware of their "ally status" by hanging a rainbow flag and sharing their own pronouns.

A recent report "Self -Generated Child Sexual Abuse Material: Youth Attitudes and Experiences in **2020"** showed that in 2019 6% of 9-12 year-olds reported explicit selfsharing generated images. In 2020 it was up to 14%. In the 13-17 year range the numbers were 15% in 2019 and 19% in 2020.
