Her goal is to prevent parents from requesting the removal of a book. Ten Democrats have signed on as cosponsors to SB 1103.

According to the American Library Association (ALA), Pennsylvania is sixth nationally in the number of books "banned". That total? 27 — the same as North Dakota! However, no books have been banned. The ALA labels any book that is challenged as a 'banned book

News from National Scene

The DC Circuit Court of Appeals upheld the Pentagon's 2025 ban on "transgenders" in the military. This will pause a district court injunction that had blocked the policy. Now the policy can take effect as the administration appeals the lower court's decision.

The U.S. Supreme Court declined to take up the case of a Christian baker in California who was prosecuted for declining to bake a wedding cake for a same-sex "marriage". One must ask 'Why?" after they have taken up so many cases and ruled in favor of the Christian business owner!!

The school board in the Massapequa, New York district has passed a policy that protects girls' private spaces i.e. no boys in girls' locker rooms and bathrooms! NY Attorney General Letitia James wrote a letter threatening to prosecute

school board members for not bowing to the LGBTQ agenda and demanding they use an individual's "preferred pronouns," regardless of whether they are biologically or grammatically correct. She also said anyone who speaks against the LGBTQ agenda at a public meeting must be silenced and kicked out. Hmm, seems like several First Amendment right violations!!

Canyon Crest Academy, a San Diego, CA public school, rented out the school's gym to a production company called Fansly, a competitor to OnlyFans. The production company videotaped highly provocative segments during its 20 plus hour video shoot.
