News from Around PA

A former Bedford County public defender convicted in 2008 of sexual offenses against a young girl has lost his challenge to a decision by the Pennsylvania Parole Board to rescind his parole after learning that while he was incarcerated he wrote and published two books "containing sexually explicit material involving minors."

A Lancaster "gay" man is suing **Arconic**, a large Pittsburgh aluminum manufacturer, alleging he was subjected to "severe" and "pervasive" workplace harassment.

Governor Josh Shapiro and Keystone Planned Parenthood are praising the preliminary ruling from Boston's U.S. District Judge Indira Talwani (an Obama nominee) to restore Medicaid money to facilities that perform abortions.

Delaware County has passed a so-called non-discrimination policy which includes 'sexual orientation and gender identity'

language. This will directly impact employment, housing and public accommodations.

News from National Scene

Matthew Platkin, **New Jersey's Democrat attorney general**, issued a subpoena to First Choice Women's Resource Centers demanding they surrender the names and addresses of its donors. The pregnancy center sued and the US Supreme Court heard oral arguments in the case this week.

A Christian pre-med student at the **University of Oklahoma** has filed a religious discrimination complaint against the school alleging that a trans-identifying teacher assistant failed her for saying in an opinion essay that God only made two genders and the idea of changing one's gender is a satanic assault against that design. Oklahoma Governor Kevin Stitt has gotten involved in the case on behalf of academic freedom.

The once married and father of a son and daughter **pastor of North Chili United Methodist Church** in Rochester, NY Phillip Phaneuf, recently announced, "I get to announce with joy that I'm

transitioning. I'm affirming and saying to all of you that I am transgender. And so, the best way to put this is that I'm not becoming a woman. I'm giving up pretending to be a man." His announcement was met with sympathetic whoops and amens!
