News From Around PA

Five days before Christmas 2017 **Emmaus Boro** (Lehigh County) received a letter from Americans United for Separation of Church and State complaining about the nativity scene in front of the Emmaus Public Library. Guess what happened this year! It has been moved to the Emmaus Moravian Church!! This was NOT necessary – all Emmaus had to do was add some secular items to their nativity scene.

Three openly **LGBT candidates** – Henry Sias, Tiffany Palmer, Wade Albert - have announced they will run for Philadelphia Common Pleas Court. It rules on civil, criminal and family matters.

Out lesbian, Sherrie Cohen, will run for an at-large seat on **Philadelphia City Council**. She said, “it’s past time for our community to be represented.” As if Philly City Council isn’t pro-gay enough!
