Central Bucks (Bucks County) school board flipped from a 6-3 Republican majority to a 6-3 Democrat majority in the November election. **The new board's first order of business was to rescind policies** that prohibit sexualized content in resource materials, create a process to review and remove sexualized library books, prohibit boys on girls' teams and requiring teachers take a neutral approach when discussing socio-political issues. Elections have consequences!

**Central Bucks new school board president, Karen Smith,** took her oath of office on a stack of pornographic LGBTQ books like Flamer, which she says she has not read, but believes students should have access to it! It is a graphic novel which includes characters discussing pornography, erections, masturbation, penis size, and an illustration that depicts naked teenage boys.

A **nonbinary former employee of the Social**

**Security Administration (SSA)** in Maryland has filed a federal lawsuit against the agency in Philly, since the regional SSA office covering MD is in that city. "J. Doe" claims workplace misgendering forced "them" to resign. The claimant is seeking more than \$500,000, along with a neutral employment reference letter and comprehensive LGBTQ+ antibias training for all Philly region SSA employees.

After testifying before Congress on Tuesday and refusing to condemn antisemitism, the pressure from donors, PA's GOP US House members and even Governor Josh Shapiro continued to mount on **UPenn President Liz Magill** to resign. On Saturday both Liz Magill and its chairman of the board of trustees resigned. Magill will stay on as interim president until a replacement is found and afterwards will be a faculty member at UPenn's law school.

### News From National Scene

**Barnard College' Athena Film Festival** in New York City recently closed submissions for its mentorship program. "The Abortion Pipeline Project (APP) is an annual

narrative screenplay competition for feature and short film scripts which seeks to seed and source a variety of narrative film projects which center abortion," the description states.

The **South Carolina State Treasurer** has announced the state has removed Disney from its approved investment list. The announcement notes, "Disney has abandoned its fiduciary responsibilities to its investors and customers" by joining far-left activists in "boycotting legal, taxpaying, employment-creating corporations to further Disney's political agenda."

Superintendent of Education Ryan Walters announced that the **state of Oklahoma** has cut all ties with the American Library Association.
