In order to comply with President Trump's executive order, West Point Military Academy and the Air Force Academy have both ended their "Diversity and Inclusion Studies" minors.

However, the San Antoniobased Air Education and **Training Command** went too far (possibly in a retaliatory against President move Trump's removal of DEI!??) and removed Tuskegee Airmen videos and curriculum about the Tuskegee Airmen from its military instruction. Secretary of Defense Pete Hegseth immediately stepped in and everything was restored.
