Good Bills this week: Save Women’s Sports - SB 9; Constitutional Amendment to end no-excuse mail-in voting – HB 258; **Bad Bills** this week: Teaching Mindfulness in Schools- HB 342; Setting Standards for Family Planning Services - HB 461

Governor Shapiro’s **proposed \$51.5 billion budget** proposal represents an increase of \$3.57 billion, or 7.5%, over the current year’s spending. With revenues projected to increase by just 2.8%, Shapiro’s plan would fully deplete the state’s surplus funds and would again dip into the Rainy Day Fund.

Governor Josh Shapiro has sued the Trump Administration because the feds have not given them money to lower consumer costs, plug/cap orphan wells, and reclaim abandoned mine land.
