News From Around PA

Was pornography involved? What is the school teaching? A 14-year-old has been **charged with raping a 15-year-old** at the Rowland School in Harrisburg.

Freshman State Rep Stephanie Borowicz (R-76) is circulating a co-sponsorship memo for a heartbeat bill in Harrisburg!

Philadelphia's third annual **Black Lives Matter Week of Action** included a panel discussion "Supporting Trans Educators."

Three 7th-grade students at the **Penn Alexander School** in Philly put together a short film entitled "The Gayborhood" that illustrated Philly's "gay rights movement." The students decided on the topic after noting "the shortcomings in school history books." The school's principal, Michael Farrell, helped coordinate a showing at William Way LGBT Community Center.

Pastor Pamm, a lesbian, LGBTQ activist and "ordained minister", is running in the special election for Philly's 190th Legislative District.

Thus far three homosexuals and one transgender are running for **Philly City Council**

News From National Scene

The University of Iowa had blacklisted 31 **religious student groups**. A federal court ruled that the university must stop its unequal treatment of religious student organizations in the name of "anti-discrimination."

A new American citizen from Italy used to teach Italian courses at **Emory University**. However, the school found out she held anti-Communist and anti-radical Islam views and she was fired.

The **Military Religious Freedom Foundation** says the U.S. Air Force Academy should cancel a planned speech by Chick-fil-A vice-president, Rodney Bullard, an academy graduate.

George Mason University pro-abortion student group, Patriots for Choice, has

successfully lobbied the school to begin selling Plan B in vending machines on campus. A FOIA request revealed the pills will be sold for \$30 each and the school will receive a 9% commission!

Lesbian activist, **Julia Beck**, has been thrown off the Baltimore LGBT Commission because she believes men will always be men and women will always be women!

Louisiana College, a Baptist school, is leaving the Council of Christian Colleges and Universities (CCCU) because of the CCCU's endorsement of the "Fairness for All" bill which would extend special protections to the LGBTQ crowd and take away religious freedom.
