According to State Rep Melissa Shusterman, "Crisis pregnancy centers are organizations that purport to provide medical services to pregnant women but instead engage in deceptive practices to prevent women from having abortions." Because of her beliefs, she is introducing legislation that would pregnancy prevent crisis centers from getting government money.

Harvard Medical School soon will be adding climate change to its curriculum, a decision made by its Educational Policv and Curriculum Committee. It will "examine the impact of climate change health and on health inequality, applications of these impacts to clinical care, and the role of physicians and health institutions in arriving at climate solutions."

Another Harvard Medical School course is "Alternative Sexualities in Healthcare: Providing Affirming Care for Patients Who Engage in Kink, BDSM, Fetish, Swinging, Ethical Non-Monogamy, Polyamory, and Open Arrangements." Yet another Harvard Medical School class, **"Advancing Excellence in Transgender Health:** A Course for the Whole Healthcare Team," is offered by the Fenway Institute, an LGBT advocacy organization.

On February 16th the Human Rights Campaign (HRC), the nation's largest LGBTQ lobby group, held its eighth annual "Welcoming Schools National Day of Reading: A Celebration of Stories Supporting Transgender and *Non-Binary Youth*. Not only is this event sponsored by HRC, but also the National Education Association and the National Association of School Librarians. This event is held in response to efforts by states and local school boards to ban obscene, sexually-charged books from school libraries.
