#### News from Around PA

**A coalition of civil rights and criminal justice reform groups** are calling on Governor Josh Shapiro and the General Assembly to legalize pot because it “would create jobs and generate tax revenue.”

A **Peters Township High School** (Washington County) senior has been arrested and charged with over 300 felonies including trafficking in minors, sexual extortion, unlawful contact with a minor, and distribution of child sexual abuse material. He used social media platforms, including TikTok and Snapchat, to lure the victims into communicating with him.

Recently the **Allentown Human Relations Commission** convened for a focused training session led by LGBTQ activist Liz Bradbury, Executive Director of Keystone Equality.

#### News from National Scene

On February 13<sup>th</sup> students from **Woodbridge High School** in Lake Ridge, VA

walked off campus and joined the nationwide anti-ICE protests. All 303 were punished “according to their regular code of behavior “ and suspended for three days. Good for this principal!!

**Mildred B. Poole Elementary School** is a DoDEA school on Fort Bragg. The school had hired a trans-identifying individual as a substitute teacher and teacher’s aide. He went by several names including “Roxanne Wildheart,” “Kiera Blackheart,” “Lilith Deathhowl” and wore a dog collar, an animal tail, and fetish tags. He also allegedly divulged his sexual fetishes in front of children by telling his students that he turns into a “wolf” at night, howling like a wolf, and insisting he be addressed by his “wolf character names”. The administration did nothing, after parents complained. Secretary of War Pete Hegseth stepped in and fired the “Wolf” teacher.

FBI officials, warning of a “sharp increase” in activity by the so-called **764 group** and other nihilistic violent online networks targeting children,

have issued a letter to parents to keep watch over their children. The letter says in part about the perpetrators, “They often groom victims by first establishing a trusting or romantic relationship before eventually manipulating and coercing them into engaging in escalating [harmful] behavior designed to shame and isolate them.” Most victims are 10-17 females.

An advisor to NY Mayor Zohran Mamdani stated that because owning a dog as a pet violates Islamic law, it should be banned. As part of her comments, she said, “New York City is coming to Islam.” In response, Florida Congressman Randy Fine has introduced the “**Protecting Puppies from Sharia Act**” which would prohibit federal funds from being provided to any state or local government that bans dogs as pets.
