**News From Around PA** The County of Lackawanna Transit System supplements income by its leasing advertising space on its buses. It bans all religious or political advertisements. NEPA Freethought Society sought to place an ad containing the word "Atheists" along with their web address. It was turned down and they sued. In September 2019, the 3rd Circuit held that the County transit system's rejection violated the First Lackawanna Amendment. County has just announced they will not appeal.

**Greater Philadelphia Human Rights Campaign** (HRC) Gala will take place on February 29<sup>th</sup> at the Loews Hotel. One component is Get-Out-The-Vote. PA is one of six priority states for HRC as they seek to flip the state blue. They are seeking to mobilize 57 million "Equality voters" across US. Sponsors include Campbell Soup and Philadelphia 76ers.

The Erie Bears (homosexual men) will hold this year's "Drenched Fur" event April 2-5 at **Splash Lagoon**.

News From National Scene The American Federation of Teachers "encourages" local and state chapters to back Elizabeth Warren, Bernie Sanders or Joe Biden for the 2020 Democratic nomination.

Remember 15-year-old Justina Pelletier who was, in essence, kidnapped by the Boston Children's Hospital and locked in a psychiatric ward for 16 months. The doctors there disagreed with the Tufts University Medical Center doctors' diagnosis of a rare mitochondrial disease and instead said Justina's symptoms were an induced psychological disorder caused by her parents. This week a jury cleared Boston Children's Hospital of medical malpractice and negligence.

Judge dismissed a professor's lawsuit against **Shawnee** 

**State University** in Ohio that rebuked him for not addressing a "transgender student" using the student's preferred gender terms. The school said that such language was part of his job, not speech protected by the First Amendment.

A 52-year-old man was taken to John Muir Hospital in California last month for emergency dialysis. Several hospital missteps caused the man to have a heart attack which left in incapacitated. Even though the hospital said he'd never breathe on his own again, he is. However, the hospital says these developments are 'involuntary' and is now withholding dialysis and blood pressure support!
