News from Around PA

Three politicians in **Millbourne Borough**, Mohammed Nurul Hasan, Mohammed Munsur Ali and Mohammed Rafikul Islam, have been charged with conspiring to register people who live outside the borough and to have mail-in ballots sent to themselves and then to return the completed ballots to the Delaware County elections board. This was all in an effort to fraudulently win election for mayor (Hasan) and the other two for borough council.

The **Pennsylvania Interscholastic Athletic Association** Board of Directors voted to update its policy regarding transgender athletes to comply with an executive order signed earlier this month by President Donald Trump.

The **School District of Philadelphia** plans to defy President Donald Trump's executive order by allowing males to continue competing in women's sports despite the change in PA Interscholastic Athletic Association transgender policy.

News From National Scene

However, this time it is not named after Confederate General Bragg, but after Roland Bragg a 21-year-old paratrooper from Maine, who saved four of his fellow paratroopers during WWII by stealing a Nazi ambulance, loading them in it and driving 20 miles through enemy fire to an allied hospital! He was awarded a Silver Star and a Purple Heart.

In order to combat wokeness within the **military academies**, President Trump has ordered the immediate

dismissal of the board of each military academy.

Michigan's largest hospital system **Corewell Health** announced last week they were ending so-called 'gender-affirming care, they made an about face this week and said the procedures were being reinstated.

The governing body for school sports in the **state of Maine** officially rejected President Donald Trump's new Title IX rules and will continue allow boys to play in girls' sports.
