News From Around PA
Boyertown School District students who have filed an appeal to the US Third Circuit Court of Appeals concerning the "trans-friendly restroom and locker room policy" have been compared to "racist bigots" in a friend-of-the-court brief filed in support of the policy. About thirty former and current school administrators from across the country filed the brief asking the Third Circuit to uphold the policy.

U.S. Reps. Lou Barletta, Ryan Costello, Mike Kelly, Tom Marino, Scott Perry, Keith Rothfus, Lloyd Smucker, and Glenn Thompson have joined state Senate Majority Leader Jake Corman and State Senator Mike Folmer in filing a complaint in US District Court in the **redistricting map case**. They cite an attack on the US Constitution, if the redrawn map is allowed to stand.

The nation's largest homosexual lobby group, the **Human Rights Campaign**, will host its annual fundraising dinner gala in Philadelphia this evening.

In Philadelphia, 19,113 people were reported to be **living with HIV** in 2016, plus 4,230 people in the suburbs, according to the Philadelphia Public Health Department. The department also noted that most individuals diagnosed with HIV ages 13-24 are either black or Latina.

The **Philadelphia Flyers** recently honored two LGBT advocates: Deja Lynn Alvarez, a biological male who believes he is a woman, and a member of the Mayor's Commission on LGBT Affairs; as well as You Can Play Northeast Regional Board co-chair Nora Cothren, who is "dedicated to education, outreach and support for LGBT high-school and college athletes."

News from National Scene
The **Freedom from Religion Foundation** has sent a cease and desist letter to Findlay,

OH claiming a mural is unconstitutional because it "conveys government support for religion" through the phrase "Under His wings shall you find refuge," and the corresponding Scripture reference, "Psalms 91."

The **Department of Defense** confirms that as of February 23, 2018, there is one transgender individual under contract for service in the U.S. Military.

Boone County School District in Kentucky has been caught altering evidence that would prove they are illegally discriminating against Child Evangelism Fellowship's (CEF) Good News Clubs. The school has refused to allow CEF equal access, while allowing other non-profits to use space at the school.
