Electric generating stations of **Conemaugh on the Indiana Westmoreland County line and Keystone in eastern Armstrong County** are slated to close by 2028 due to the costs imposed by the US EPA and Governor Wolf's insistence that PA enter the Regional Greenhouse Gas Initiative (RGGI). These two plants and the one in Homer City have spent billions trying to comply with EPA regulations and can power more than 5 million homes. As one employee notes, "Environmentalists ... plan to regulate us out of business, but they are not going to have electricity because there is nothing to replace us."

Flyers mascot Gritty waved the Pride flag on the ice and players warmed up using hockey sticks wrapped in rainbow Pride tape -- all part of the Flyers Pride Night on February 21.

There are currently **three Democrat candidates for Lt. Governor:** State Rep Brian Sims, State Rep Austin Davis

News From National Scene

Crowdfunding organizations like **GoFundMe** are allowing gender-confused children as young as 13 to raise funds to purchase puberty blockers and even pay for sex reassignment surgery!

Girls who are suffering from gender confusion now have a new app to **make it easier for them to do an end run around parents** and doctors to obtain the puberty blockers and/or testosterone to "Live your authentic life." For \$99 a month the service called Plume allows these girls to telechat with a Plume doctor who will ship the drugs directly to their door.

Oklahoma Attorney General John O'Connor "finds no legal basis for a state medical licensure board to discipline a licensed physician for exercising sound judgment and safely prescribing an FDA-approved drug - like

ivermectin or hydroxychloroquine - for the off-label purpose of treating a patient with COVID-19."

Student Advocates for Sexual Health Awareness at **Ohio State University** is hosting "Sex Week", but several university departments such as Department of Women's, Gender and Sexuality Studies and the College of Social Work are providing financial support. During one event, students are asked to "help thank abortion providers."

Under the direction of the National Association of Independent Schools, **private schools** nationwide are training teachers to expose kids as young as four to sexually explicit content.

Two recent **professional development sessions** were presented to teachers and staff in the Hilliard, OH school district. The presenter was a rep. from Kaleidoscope LGBT Community Center.
