News from Around PA

Mark Paterson, professor of sociology at the **University of Pittsburgh**, recently expressed concern over the lack of diversity among the robot population. Paterson worries, for example, that black children “could end up interacting with white robots.”

In 1985 the PA Supreme Court upheld a **law banning the use of state Medicaid dollars for abortion**, except in cases of rape, incest or to save the life of the mother. Now in a 3-2 decision the court revived a challenge to the law saying a lower court must hear a challenge to its constitutionality.

The **Human Rights Campaign**, the nation’s largest LGBTQ lobbying group, recently issued its “State Equality Index”, a comprehensive “state-by-state report that provides a review of statewide laws and policies that affect LGBTQ+ people and their families.” Pennsylvania came in 25th.

Moriarty’s Irish Pub on Walnut Street in Philly has been reported to the Philadelphia Commission on Human Relations for violating the Fair Practices Ordinance for placing an ad looking for a “biologically male” bartender. The pub is located in the Gayborhood and the owner’s actions have been deemed ‘transphobic’.

News From National Scene

The track and field records for the **Rochester Institute of Technology** were recently broken – by a “transgender female”, a biological male. Last year he ran the same course in the men’s race and came in 19th. Since then, he “decided” he was really a female and has now destroyed the 200 and 300 meter women’s records!

The project, “**Improving the Accessibility of Transgender Voice Training with Visual-acoustic Biofeedback**,” aims to improve “gender-affirming voice and communication training (GAVT” with “novel GAVT software” that coaches men on their “pitch and resonance” through voice exercises. Guess what?? The project, led by a transgender professor, received a NIH grant for \$213,878 in

taxpayer funds for the effort. The federal agency lists the project as “research related to deafness and communication disorders”, but has failed to answer how that description applies!

Utah Governor Spencer Cox signed legislation that bans DEI programs in the state government and public universities. He also signed a law that bans boys who identify as girls from entering girls’ private spaces.

University of Colorado Boulder Theatre Professor Beth Osnes fights her “**climate anxiety**” by dressing and performing as a butterfly! She also teaches environmental studies classes and became “increasingly discouraged about the perilous state of our planet.”
