Prevention Meets Fashion will host its 9th annual **Condom Fashion Show** on Saturday, Feb. 21 in Philadelphia- "welcoming 16 designers who have created wearable looks out of condoms." But, the organizers say this is a "family-friendly" show!

Swarthmore College

(Delaware County) student athletes signing required paperwork for next school year found the NCAA guidelines regarding participation for "trans-student athletes", which changed in March 2025. The document clarifies that Swarthmore plans to abide by the NCAA rules which require athletes to play on the teams that correspond with their biological sex. Some students are concerned that they are being asked to sign an acknowledgement of the

policy and are questioning the school's commitment to "inclusion" and no longer feel safe on campus.

Pittsburgh Pride has announced its 2026 theme "Existence is Resistance". It will run from June 5th thru 7th.

News from National Scene

The nonprofit organization **Them Before Us** is spearheading a coalition to overturn *Obergefell* on the grounds that it victimizes children. Our many warnings that legalizing "same-sex marriage" would harm children have proven true. Children are the overlooked causality of this Supreme Court's decision.

During the **National Prayer Breakfast** on February 4th President Trump made the following announcement: *"On May 17th, 2026, we're inviting Americans from all across the country to come together on our National Mall to pray, give thanks, and rededicate America as One Nation Under God."*

An **Ohio YMCA** is refusing to protect minor girls from an adult male employee who makes no effort to hide his arousal while wearing a women's bathing suit

and ogling young teenage girls at the pool.

In a unanimous decision, a three-judge panel for the **4th Circuit Court of Appeals** vacated a lower court's decision which would have blocked President Trump's efforts to eliminate racist DEI programs in federal contracting.

The nation's largest LGBTQ lobby group, the **Human Rights Campaign**, (HRC) reports the number of Fortune 500 companies willing to publicly disclose their diversity, equity, and inclusion (DEI) practices has dropped 65 percent in the last year. Despite the drop in Fortune 500 companies, 1,450 companies still participated in HRC's Corporate Equality Index. Of that number 534 received a perfect score from HRC!!
