Pine Richland School District (Allegheny County) is **being sued by America First Legal** on behalf of a parent who requested in writing that "absent her prior written consent, the School District shall not refer her child to any mental health counselor or social worker for evaluation and that the School District notify her of any matters related to the "gender identity" or "gender dysphoria" expressed by her child." She met with the principal and guidance counselor and they said they would NOT notify her if her child expressed any gender confusion!

The **PA Department of Health** reports that abortions are up in PA. Additionally, abortion complications have tripled in the last five years.

A commission reviewing how **PA distributes money** to public schools says the state is under-funding districts by more than \$5 billion and should close the gap now.

The Barn, a wedding venue in Kansas owned by Christians, **agreed to allow two lesbians get "married"** in The Barn. However, the co-owner wrote, ""While our deeply held religious belief keeps us from celebrating anything but marriage between a man and woman, we desire to serve everyone equally and do not want to keep anyone from using our building who would like to". This response enraged the lesbian couple and they posted their story on social media and the venue has been inundated with hate mail from LGBTQ activists!

Actor, writer, director **Ricky Schroder** recently founded the Reel American Heroes Foundation (RAHF) in response to the lack of conservative values in the media. RAHF has also established the Council on Pornography Reform, which is dedicated to creating a safer and more responsible digital environment, particularly for younger audiences.

A **transgender professor** who at various times has used

"they/he," "ze/zim/zer," and "he/him/his," pronouns reportedly provided "cultural inclusion" training to IRS criminal investigators. This individual currently chairs the higher education department at the University of Denver!
