**News from Around PA**  
**Lancaster County Amish farmer Amos Miller** will be able to continue selling his organic meat to his 4,000 private food club members, after recently winning a major court victory on appeal against the US Dept. of Agriculture. The USDA began pursuing Miller in 2021 for selling "adulterated meat," which means food that has not been treated with the USDA's chemical cocktails. All USDA- licensed processing plants are required to lace their food products with synthetic preservatives.

**Penn State sociology professor** Sam Richards challenged his students to watch gay porn to see how quickly they'll "feel aroused". Arguing that everyone is "at some level non-binary" and "easily bisexual."

**Penncrest School District board** (Crawford County) passed, by a vote of 5 to 3, a policy that requires the district to prioritize materials "that do not contain sexualized content" in selecting library materials. They also explicitly prohibit

material that contains "visual or visually implied depictions of sexual acts or simulations of such acts; explicit written depictions of sexual acts; or visual depictions of nudity — not including materials with diagrams about anatomy for science or content relating to classical works of art." The LGBTQ crowd said such a policy was targeting them! They also approved a policy by the same 5-3 vote that prohibits biological males from playing in girls' sports.

#### News From National Scene

A Christian activist will have to wait until the end of 2023 to table in the **University of Wyoming's** student union due to a one-year ban for referring to a transgender student by name and calling him a "male."

A **Christian pharmacist with CVS** is suing her former employer for suddenly denying her a religious exemption when it came to prescribing contraception and abortifacients. They had provided that exemption for over six years!

Forty-four **current and former college students who**

**identify as LGBTQ** at **religious schools** sued the US Department of Education to force them to drop the religious exemptions under Title IX saying the they were incompatible with LGBT rights and exposed them to "unsafe conditions" at religious schools. The plaintiffs argued that the exemptions sent the message that LGBT discrimination was "endorsed by the federal government" since the schools receive federal dollars. An Oregon judge dismissed the lawsuit.

The **US DOE** is launching an investigation based on an ACLU complaint against the superintendent of the Granbury Independent School District (Texas) for removing explicit books from the district libraries. His actions were fully supported by the school board.
