#### **News From Around PA**

Eight men have filed a federal lawsuit against the **Boy Scouts** on behalf of over 1500 men who have come forward in the last 11 months to tell about the sexual abuse they endured while Scouts. Two were from Lawrence County - Troup 712 in 1998 and Troup 806 in 2003.

**Allegheny County Board of Elections** will be purging 69,000 inactive voters from rolls. However, they admit that 140,000 -- more than 15 percent - are inactive!

Central Outreach Wellness Center -- **an LGBTQ clinic** - has offices in Allegheny and Washington Counties, but recently expanded into Aliquippa, Beaver County.

**Christian Counseling Associates** recently announced a second location in Harborcreek, Erie County.

In November Democrats took control of the **Delaware County Council**. One of their first acts, after being sworn in, was to join Chester County in declaring they were a "sanctuary county."

Presidential candidate **Elizabeth Warren** has opened an office in the Cedar Park area of West Philadelphia. She has hired out LGBTQ activist Anne Wakabayashi as Pennsylvania state director. Wakabayashi is also executive director of the progressive group Emerge PA and chair of Governor Wolf's Commission on LGBTQ Affairs

#### **News From National Scene**

Beginning this month, students in 12 New Jersey schools will be part of an **LGBTQ-inclusive curriculum** pilot program. By next September all schools will be required to teach the interdisciplinary curriculum that was devised by NJ teachers and pro-gay LGBTQ Garden State Equality.

Democrats are funneling \$50 million into an effort to flip state legislatures before congressional redistricting maps are redrawn based on the 2020 census. PA is on their target list!

A large cross was dedicated in **Effingham, IL** soon after the 911 attacks in 2001. A mural was inspired by that cross and it, as well as an American flag, is painted on an overpass in the city. The Freedom From Religion Foundation is demanding the mural be removed.

Judge Loretta Biggs, an Obama appointee, has thrown out **North Carolina's voter ID law**.

**TN Governor Bill Lee** has signed into law a bill protecting the right of adoption agencies in the state to place children only in homes with both a mother and a father.

**Scottsdale, Az** is being sued for refusing to cave to the demands of the Satanic Temple to lead the invocation at the city board meetings.
