The viral picture of a co-teacher at Pennfield Middle School (Montco) **taping a mask to the face of a student** has created a skirmish between rival parent groups North Penn Stronger Together and North Penn Neighbors for Progress.

The **LGBTQ+ Equality Caucus** in the General Assembly consists of members of both the GOP and Democrats in the Senate and House.
