State Senator Steve Santarsiero (D-10) has announced that \$630,000 in state funds (taxpayer dollars!) will go to The Rainbow Room in Doylestown. They are also looking at a potential second location in Lower Bucks County. It's a LGBTQ+ youth center and an initiative of Planned Parenthood Keystone.

Senator Doug Mastriano is working to introduce a bill that would classify drag shows as an adult-oriented business under Title 68.

Altoona School District (Blair County) is following the lead of the Pittston Area School District (Luzerne County) in authorizing its "police officers" to have access to AR-15s. The superintendent says, "The purpose is so that if there is a situation, heaven forbid, they will have access to what they need equipment wise to deal with it." Semiautomatic weapons were used in the 2018 shooting at Marjory Douglas High School and the 2012 shooting at Sandy Hook Elementary School.

State Senator Steve Santarsiero (D-10) was listed as a sponsor of a "queer prom" hosted by The Rainbow Room. There was a drag performance; the underage attendees were given gift bags containing condoms, lubricant, dental dams, tarot cards, candy, a pendant, a "progress pride" flag, and Planned Parenthood informational material. When asked about his sponsorship, Santarsiero responded that he was "proud to support the Rainbow Room's annual Queer Prom for LGBTQ youth

News From National Scene

The school counselor at **Pendleton Heights High School** in Madison County, IN, who exposed the school's "Gender Support Plan" and policy to conceal student transgender procedures from parents, has been placed on indefinite leave and possible termination.

The "NOW" statue, a naked, golden woman with braids fashioned into horns coming out of her head as she emerges from a pink lotus, currently stands on top of a New York City courthouse. It is meant to pay homage to the late Supreme Court Justice Ruth Bader Ginsburg, a fierce defender of abortion.

The artist titled the piece "NOW" because "women's ability to have abortions is at risk right now". The statue's next stop is Houston, TX.

A liberal English professor at **Western Kentucky University** was fired after he cancelled classes in protest of the school's political bias to embrace and enforce diversity, equity and inclusion above free speech and academic freedom.

The new owner of the **Miss Universe organization** recently extolled the organization as run by women, for women and composed of women. There's only one problem: the new owner is a "transwoman" – a biological male!
