News From Around PA

Commonwealth Court panel in a 3-2 decision declares the **no-excuse mail-in ballot portion of Act 77** as unconstitutional. The Wolf Administration is expected to appeal to the PA Supreme Court, where the 5-2 Democrat majority will likely reach a different conclusion. (Read Article VII Section 14(a) of the PA Constitution!)

Last September the **Chambersburg Borough Council** (Franklin County), by a vote of 7 -3, passed an “anti-discrimination” ordinance giving special rights to homosexuals and transgenders. Following the November election conservatives had taken control of the council and on January 24th voted 7 to 3 to repeal the ordinance becoming the first in PA to do so!! Protections to certain groups should not be based upon changeable characteristics such as sexual orientation or gender identity, but upon unchangeable characteristics such as race or ethnicity.

Those protections are already in state law!

University of Pennsylvania’s **former male swimmer who now identifies as female** continues destroying women’s swimming records, most recently easily winning the 200-meter and 200-meter freestyle against Harvard. The NCAA that oversees collegiate athletics in the US, claims that “there is nothing that would preclude Lia from racing in March at the NCAA Championships.”

University of Pittsburgh hired Hyman, Phelps and McNamara, a DC based law firm, to conduct an investigation into their researchers’ compliance with state and federal laws when it came to the use of human fetal tissue.
