#### **News from Around PA**

Did you know Pennsylvania voter rolls includes an estimated **100,000 non-citizens**? The Third Circuit Court of Appeals denied the Public Interest Legal Foundation access to the voter information claiming they did not have standing. The US Supreme Court has been asked to reverse the Third Circuit decision.

**Philly Councilmember Rue Landau** — the city's first openly LGBTQ+ member— is teaming up with Councilmember Kendra Brooks to introduce legislation that would limit the way Immigration and Custom Enforcement (ICE) can operate in the city.

The Philadelphia Theatre Company, Arden Theatre Company, Delaware River Waterfront Corporation, and Philadelphia Dance Projects have received grants from the **Pew Center for Arts & Heritage** for “a sustained investment in queer-led performance as both artistic

practice and cultural preservation”.

#### **News from National Scene**

Recently the **Washington Capitals** celebrated alternative sexual lifestyle night “All Caps, All Love”. As they took the ice against the Florida Panthers, viewers noticed only eight of the Capitals' 20 dressed players took part in showing their “pride.” All of the players that participated were from either the US or Canada; none of the Capitals players born overseas participated.

**Fox Varian** sued her Westchester, NY, area psychologist and plastic surgeon for the gender-transition mastectomy she got at 16. She had a turbulent childhood. She was diagnosed with autism and suffered from depression, anxiety, social phobia and began questioning her gender at age 15. Her psychologist's answer was surgery! Fox just won \$2 million in her lawsuit against those who ruined her life!

#### **New York Attorney General**

**Letitia James** just fired Glenna Goldis, the assistant attorney general at the NY Consumer Frauds and

Protection Bureau. Goldis, a lesbian, understands the danger to children the transgender agenda poses. And she claimed James fired her “for speaking out against pediatric gender medicine.”

A bill proposed by **Virginia Democrat Del. Sam Rasoul** would require courses taught at public schools to push the “contributions, perspectives, and experiences of historically marginalized communities, including . . . individuals who are lesbian, gay, bisexual, transgender, and queer (LGBTQ+).

The **Minnesota Department of Education** and the Minnesota State High School League are continuing to allow males to compete in girls' sports and enter female-only facilities. The case has been referred to the U.S. Department of Justice for enforcement action.
