A **Dunkin' Donuts** in **Bethlehem** has asked a federal judge to dismiss an antibias lawsuit brought by a former employee - a "transgender woman," really a biological male. During the three months he was employed he claims he was misgendered and prevented

from using the women's bathroom after a customer complained. FYI: Previously Bethlehem passed a LGBT special protection ordinance.

The medical provider for the **Lackawanna County prison** seeks dismissal of two federal lawsuits filed by transgender inmates who allege they were denied hormone therapy.

**News From National Scene**  
Lawmakers in **Georgia, Tennessee and Washington** have proposed legislation that would place restrictions on boys in girls' sports, etc.

Acting Secretary of the **Dept. of Homeland Security** ordered a review of state laws allowing illegal aliens to obtain driver's licenses.

The Trump administration **issued 2,964 final rules** in 2019. This is the lowest count since records started being kept in the mid-70's. Some of those 'rules' are written to get rid of or replace others!

The **United Methodist Church** has officially announced it will be splitting over the homosexual issue. Those who hold Biblical understanding of sex and marriage will form a new
