**News from Around PA**

Three PA State Troopers and seven employees of the PA Department of Agriculture conducted a search warrant on independent farmer **Amos Miller's property** (Lancaster County). Miller operates a private buying club providing customers with sustainable alternatives to commercially produced food. His products are only available to members of the club and not the public; his buyers knowingly purchase his raw products and accept any associated risks. Miller said in 2022 that his customers don't trust the large corporations. The PA Department of Agriculture contends that Miller had not filed for applications they wanted him to. Thirty-seven items were removed from his farm and a notice was left on a large walk-in cooler, which contains most of Miller's products, that the food in the cooler "has been detained by the PA Department of Agriculture". His attorney notes that resolutions had been reached with the federal government, which the state ignored. He also noted that a high-ranking state official that has a

grievance with independent farmers is responsible for obtaining the search warrant.

**Democrat activist, Gene Stilp**, has filed a challenge in an attempt to keep Congressman Scott Perry (PA-10) off the ballot, citing the 14<sup>th</sup> Amendment and Perry's role in "denying the outcome of the 2020 election".

**South Western School District's** (York County) new board consists of five conservative Republicans and, shortly after they were sworn in, they made known their intention of removing "gender identity" from the district's sexual harassment policy. This would keep boys out of girls' bathrooms.

Last year **Quarryville Library** (Lancaster County), which serves 10 municipalities, lost funding from Fulton Township because it refused to remove LGBTQ+ books. East Dunmore Township has announced it will no longer be funding the library either.
