News From Around PA

Conservative **State Rep Daryl Metcalfe** (R-12), chairman of the Environmental Resources and Energy Committee, has announced he will not seek re-election.

State Senator Doug Mastriano has announced his candidacy for PA governor.

GOP State Senator John Gordner made a motion to renominate **Jake Corman for the Senate Pro-Temp** position. Democrat Senator Jay Costa seconded the motion. A voice vote was taken and the only audible 'no' was from Senator Doug Mastriano. Since we don't have a paper trail to follow on this vote, you may want to call your State Senator and ask how he or she voted!

The **Philadelphia 76ers** hosted their annual Pride Night on January 3rd at Wells Fargo Center. Their mascot donned a More Color, More Pride rainbow cape. During the halftime celebration, a video celebrating LGBTQ history was played for the audience.

PA's name-change law as it relates to **restrictions for convicted felons** has been declared unconstitutional by Allegheny County Common Pleas Judge Christine Ann Ward. Three transgender felons challenged the law. AG Josh Shapiro does not intend to appeal the decision.

News From National Scene

Globally **abortion killed** 12 times as many people in 2021 as COVID did! Over 42.6 million died from abortion, while approximately 3.5 million died from COVID.

Last month a report was released by the **Institute for Pro-Life Advancement**, a project of Students for Life, which revealed that more than 100 Christian colleges and universities in the US have had ties to Planned Parenthood in the past two years. The promotion of PP constituted 56% of all infractions.

Focus on the Family has told employees that they must soon reveal whether they've gotten a COVID-19 shot.

In response to a **Freedom of Information Act** request for data submitted by Pfizer to license its COVID-19 vaccine, the FDA wanted to release

500 pages per month. The full response would have taken 75 years!! A federal judge has rejected this and has ordered that 55,000 pages per month be released.

Last month the US Senate passed a resolution to **overturn President Biden's COVID -19 vaccine mandate**.

It only required a simple majority- Senators John Tester (D-MT) and Joe Manchin (D-WV) joined all the GOP. Speaker Nancy Pelosi does not plan to bring it up in the US House and Biden is sure to veto if it was to pass the House!!
