A federal court jury awarded \$2.8 million to a woman who was sexually abused by a coach when she was in middle school in the **Loyalsock Township School District** (Lycoming County). They have asked U.S. Middle District Judge Matthew W. Brann to order a new trial or reduce the award.

Though the US Supreme Court ruled that states can ban males from female sports, **PA will still allow boys in girls' sports** until Senate-passed SB 9, the Save Women's Sports Act, passes in the State House. For 14 months the House Democrats have bounced the bill back and forth between committees. The latest move was on July 1st back to Health Committee!

News from National Scene

Five years ago **Bethany Christian Services** began licensing LGBTQ+ people to

serve as foster and adoptive parents. However, they have reversed course saying they would not license or re-license anyone who does not agree to a Statement of faith and belief. It states, in part, that marriage is "a covenant between one man and one woman" and that "God creates human beings in His image as male and female, as determined by biological sex."

Under the **"Teen Pregnancy Prevention Program"**, which began in 2010 under President Obama, the U.S. Department of Health and Human Services (HHS) awarded federal grant money to "evidence-based programs" designed to prevent teen pregnancy and sexually transmitted diseases. One of the recipients was Planned Parenthood! Surprise, surprise - evaluations showed the programs generally turned out to be either ineffective or increased pregnancies and STDs!! HHS has cancelled those grants and announced two new grant opportunities that promote body literacy in place of radical gender ideology, abortion, and contraception.

After the **US Supreme Court's** opinion allowing states to ban males from female sports, the collegiate sports organization NCAA announced it will continue its January 2025 policy which banned males from female sports.

The **Presbyterian USA's** 227th General Assembly voted 441-30 in favor of an overture called GEN-02, also known as "On Access to Healthcare." This measure included language denouncing state bans on so-called "gender-affirming care" for minors and called mutilation of gender confused minors 'medically necessary'!
