News from Around PA

The Trump administration paused \$175,000,000 in federal funding to the **University of Pennsylvania** in March. It has now announced it will comply with President Trump's executive order banning males who identify as females from participating in women's sports. Additionally, it will strip "Lia" Thomas of all titles and awards won while competing as a woman swimmer.

As part of a nationwide effort to make sure laws are being properly followed, the **U.S. Department of Justice** is asking PA for 14 categories of information on the state's voter registration activities, including how voters are added to and removed from the voter roll, and how the state prevents unauthorized access to its system.

Recently the **Upper Adams School Board** (Adams County) voted 6-3 to adopt a revised version of Policy 109.1

"Selection of Materials for Libraries/Media Centers". Under the updated policy, the district "will avoid library materials with sexually explicit content" and/or "excessive profanity." It also states that materials that "disparage religious beliefs" will be avoided.

In an effort to stall a vote on the bill, Democrats re-referred SB 9, the **Save Women's Sports Act**, from the House Education Committee to the House Health Committee. The vote was along party lines 14-12.

News from National Scene

The **Federal Trade Commission** hosted a workshop this week in Washington, D.C., examining the dangers of so-called gender-affirming care. During the workshop, the Justice Department's Chad Mizelle announced that the agency has issued nearly 20 subpoenas against clinics that are engaged in transgender transition attempts.

Baylor University (a Baptist school) in Waco, Texas, has received a \$643,401 grant from a liberal foundation to foster inclusion among

LGBTQ-identified individuals in the church.

The first of President Trump's judicial nominee in his second term has been confirmed. Whitney Hermandorfer was confirmed for the **Sixth Circuit Court of Appeals**. She clerked for three US Supreme Court Justices: Alito, Barrett and Kavanaugh. Most recently, she successfully defended Tennessee's law banning so-called gender affirming care before the US Supreme Court.

Primary Health Care, a federally funded health care facility in central Iowa, recently announced it would no longer provide hormone replacement therapy care "(d)ue to a recent Executive Order restricting use of federal grant funds from being used for gender-affirming care."
