Pampered Chef is holding a fundraiser with 30% of the proceeds going to **'Aging with Pride Erie'**.

The Stonewall Inn PGH, "a dedicated space for Transgender individuals seeking gender-affirming care and support", is moving into downtown Pittsburgh.

Pittsburgh-based **Adagio Health** has been recognized as a "High Performer" healthcare provider by the Human Rights Campaign (the nation's largest LGBTQ lobby group) for its "inclusive service to the LGBTQ+ community".

Temple University's director of undergraduate studies in the School of Media and Communication founded the school's "NYC Study Away" program, where students learned about LGBTQ+ history, and then got to be involved in planning and implementing New York City's Pride march. Temple students make up the largest contingency of any educational institution present at NYC Pride.

From National Scene

The recent case *Missouri Department of Corrections v. Jean Finney*, involved a lesbian who sued, claiming her employer fired her because she was too "masculine." Potential jurors were asked if they attended a church which taught engaging in homosexual acts was sin. Two responded they were Christians and believed what the Bible said. One responded that according to Scripture homosexuality was sin, but "so is gossiping, so is lying." Another responded, "Every one of us here sins. ... It's just part of our nature," therefore everyone deserves grace". Both potential jurors were dismissed because of their Scriptural beliefs

President Biden nominated **U.S. Magistrate Judge Sarah Netburn** to serve on a New York district court. In 2022 she recommended the transfer of a 6'2" male convicted rapist to a woman's facility because he now identified as female. The Senate Judiciary Committee rejected the nomination by a vote of 10-11 - a first. The Senate has already confirmed

202 of Biden's judicial nominees!

A **Montana law** defining sex as only male and female was deemed unconstitutional.

OpenTheBooks, a government spending watchdog, finds congressional hearings have not stopped Pentagon "diversity, equity and inclusion" policies that include helping soldiers' kids get transgender surgeries and hormones without their parents' knowledge. And children continue being indoctrinated with gender ideology in the 160 schools operated by the Pentagon's Education Activity agency.

US House votes 210 to 205 along party lines to undo the **US Dept of Education** redefinition of the word "sex" in Title IX.
