Liberal Democrats in the State House have introduced **HB 1562**. It would amend the state constitution to establish health care as a human right in PA. Of course, we know to them healthcare includes abortion and “gender affirming care” for minors!

Pennsylvania is one of 36 states that provide healthcare coverage for **transgender-related procedures** for state employees.

An amendment that would **reverse the Pentagon’s policy** to reimburse travel expenses for service members who get abortions was added to the National Defense Authorization Act. Only two Republicans voted against it. One of those was Brian Fitzpatrick from Bucks County

With the intention of amplifying the stories of LGBTQ+ people of color, members of Malvern-based **People’s Light** are launching Queerways. It will advance theatrical works based on stories by LGBTQ and BIPOC

communities in the Greater Philadelphia region.

News From National Scene
Arkansas Governor Sarah Sanders’ children made a chalk drawing outside their residence – the governor’s mansion. Americans United for the Separation of Church and State cried ‘foul’. What was the offending drawing? It was the depiction of a cross in a stained-glass style. The governor’s answer to the group’s demand letter it be removed was a simple ‘NO’.

School-based health centers in Seattle are offering middle and high school students “gender-affirming care” - cross-sex hormones and referrals for surgery - as part of their medical services provided at school.

Planned Parenthood is offering \$150 gift cards for participation in a “Sex Ed Summer Camp”, which “ is a sexual health peer education certification program” to be held July 24-28 in Mankato, MN, reads an application page. “Topics covered include sexual anatomy, birth control methods, sexually transmitted infections,

healthy relationships and consent, and more!”

Judge Lynn Adelman in the **Eastern District of Wisconsin** has issued a temporary restraining order forcing Mukwonago Area School District to allow a male student into girls’ restrooms.

The Providence, RI Public School District has barred Child Evangelism Fellowship from having clubs in their elementary schools, while allowing other clubs to meet. Apparently, the board has never heard of the U.S. Supreme Court June 2001 decision in *Good News Club v. Milford Central School* in which it ruled that public schools violate the First Amendment by not providing equal access and equal treatment to Christian clubs when the school has opened the forum to secular clubs!
