News from Around PA

Dick's Sporting Goods, based in Pittsburgh, has been hit with a civil rights complaint for funding employee abortions, but not childcare.

UPenn transgender female (biological male) swimmer **Lia Thomas** has been nominated for the NCAA Woman of the Year Award!

Governor Wolf has signed a bill into law that would ban third party entities from providing funds to county election operations, i.e. Mark Zuckerberg's Center for **Tech and Civic Life** which gave grants to at least 21 PA counties in 2020.

Chester County mom of a **Greater Valley School District** student is suing the school district for exposing her son and others to sexually explicit materials in the school library. She and other parents tried to enter the Capital Building in Harrisburg carrying enlarged images from school library books, but were turned away by Capitol police who told them the images would offend people

and children could see them! She is also seeking a nationwide ban on such materials in school libraries.

The legislature has passed **five constitutional amendments:** require showing ID every time you vote; allow a gubernatorial candidate to pick his running mate for lieutenant governor; comprehensive auditing of elections by the state auditor general; allow Legislature to reject proposed regulations without approval of the governor; should taxpayer dollars be used to fund elective abortions. Remember the same language must be passed in the next legislative session before the voters get to vote on them, thus the earliest would be May 2023.

A **Nonbinary People's Day Celebration** at West Philly's Clark Park will be held on July 17th from 1-5 p.m.

Pittsburgh City Council unanimously gave preliminary approval of two of the three abortion bills: shield abortionists who perform abortions from out-of-state prosecution; a "trigger law" that instructs police to "deprioritize" the

enforcement of abortion laws should abortion be banned in PA. The third would prohibit "deceptive advertising" by crisis pregnancy centers. Three councilors abstained from voting on this bill, while four approved it.

News From National Scene

The **National Education Association (NEA)** and the **ACLU** both claim children are "never" too young to undergo so-called sex change surgery. The claim is in the document "Schools in Transition: A Guide for Supporting Transgender Students in K-12 Schools".

Under the CDC's LGBT Health Youth Resources, they link to **Q Chat Space** which is available for those ages 13-19. That website discusses sex, sex change operations, LGBTQ activism, the occult and polyamorous relationships.
