Between California, New Jersey, Nevada and Pennsylvania, the **Department of Homeland Security** has found 250,000 illegal aliens registered to vote - 14,576 in Pennsylvania alone! Daughters of the American Revolution (DAR) was founded in 1890 because Sons of the American Revolution refused to allow women into their ranks. Now 136 years later, DAR is confused as to what a woman is! In 2023, organizers of DAR changed the bylaws barring local chapters from discriminating on the basis of gender, religion, or sexual orientation. According to the new bylaws, any man identifying as a woman would be admitted to DAR as long as his birth certificate had been changed to indicate his new identity. Other leaders and members were outraged! Rep. Ben Kline (R-VA) has introduced Daughters of the American Revolution Membership Integrity Act,

which would amend DAR's congressional charter to ensure biological men cannot become members.

The recently released Netflix's series **Little House on the Prairie** rewrites the Laura Ingalls Wilder's book the series is supposed to be based on. Don't let anyone you know watch the show unless they've read the book and know what the Ingalls family was really like!
