News from Around PA

This week - Bad Bill: HB 1677 – protecting “trans kids” and their families

A federal judge sentenced two former **Millbourne Borough** (Delaware County) elected officials to prison for election fraud related to a 2021 mayoral election.

Sixteen counties and cities in Pennsylvania are on a list of jurisdictions which the **Department of Homeland Security** says is obstructing the deportation of illegal aliens. These will receive a “formal notification” of its violations of federal law.

Gettysburg High School tennis coach David Yates changed his name to “Sasha” in 2022. He was not rehired following several incidents including allegedly “stripping down to bra and panties” in the girls’ locker room. He later reapplied for the job and, after the solicitor warned the district may be sued for discrimination due to ‘transphobia’, the board voted 6-2 to rehire him.

Months later he resigned over a pornographic video.

News from National Scene

A Virginia circuit court struck down the **state’s ban on talk therapy** for gender-confused minors citing it as a violation of the state’s constitution and religious liberty laws.

Legislation will soon be introduced in the US House and US Senate to revoke the **National Education Association’s** federal charter. Sponsors noted that the organization has become more interested in pushing woke policies than in educating our children.

Delaware has become the 12th state to legalize **physician assisted suicide** for terminally ill adults with a prognosis of six months or less to live, going into effect January 1.

The **MO Supreme Court** issued a ruling that could reinstate the state’s abortion safety standards by requiring the case be reevaluated under stricter legal standard.

According to **Operation Rescue**, right now, all 236 Department of Defense Commissaries are selling the abortion drug Plan B.

In June 2022 Portland State University Professor Bruce Gilley responded to a **University of Oregon Division of Equity and Inclusion** “racism interrupter” post on Twitter by retweeting it with the comment “all men are created equal.” Rather than recognize those words from the Declaration of Independence as protected speech, a university DEI official blocked Gilley from the @UOEquity account. He sued and the school must now pay him \$724 million!

A **recent survey** from Intelligent found that “1 in 4 hiring managers say recent grads are unprepared for the workforce” and “1 in 8 managers [are] planning to avoid hiring them in 2025.” The main reasons for this are lack of preparation, a so-so work ethic, and a sense of entitlement among the grads.
