News From Around PA

TransFamily will hold its third annual picnic at the Wilson Picnic Grove at Penn State Behrend in Erie today.

A **"Gay Day"** was held in Diamond Park in Meadville (Crawford County) on July 13. It is believed to be the first pride event in the county.

The US House has passed an amendment to the **National Defense Authorization Act** which would reverse President Trump's policy on transgenders in the military. Brian Fitzpatrick (PA 1) was one of 10 Republicans who joined all Democrats.

Recently the **PA Human Relations Commission** held a "No Hate in our State" town hall meeting in Hanover (York County). The topics included racism, sexuality, gender, politics and religion.

The PA Human Rights Commission will soon be conducting a **67-county tour**

to talk about "diversity and inclusion." (Note: These are usually buzz words used by LGBTQ+ activists!)

Federal obscenity laws have not been enforced for decades now and we see an increase in **child porn prosecutions** as porn consumers seek more deviant material to reach their 'high.' Recently a Monroe County man, previously convicted of possession of child porn was indicted by a federal grand jury on the same charge

News From National Scene

St. Louis Park, MN city council has unanimously voted to reinstate the reciting of the Pledge of Allegiance at the beginning of meetings.

More than **200 major U.S. corporations** have signed on to an amicus brief asking the Supreme Court to rule that the word "sex" under Title VII of the 1964 Civil Rights Act includes "sexual orientation" and "gender identity." Such a ruling would make it a federal crime if an employer fired someone for being transgender or homosexual.

New Business Item 56 at the NEA Convention was approved, It declares the NEA ". . . vigorously opposes all

attacks on the right to choose and stands on the fundamental right to abortion under Roe v. Wade."

Ohio HB 90, the Humanity of the Unborn Child bill, was introduced. It requires fetal development information be taught in public schools. The hope is it will increase respect for human life and for the purpose of "achieving an abortion free-society."

New York City public school Schools Chancellor Richard Carranza says students in the 2019-2020 school year will be able to "self-report names and genders" when enrolling. Once the families submit their "name and gender change request form," every piece of school-related data i.e. report cards and diplomas will reflect this change!
