#### News From National Scene

The **US Dept. of Health and Human Services** sent 'guidance' to 60,000 pharmacies nationwide stating if a pharmacist refuses to fill an order for mifepristone or misoprostol "because these medications can also be used to terminate a pregnancy - the pharmacy may be discriminating on the basis of sex".

The **Department of Justice** entered a \$1.5 million contract with a private company to develop a "transgender programming curriculum" to be used in prison across the country. It will teach "techniques to seek support for mental health concerns and skills to advocate for physical, emotional, and sexual health and safety." They are also to develop a program to help transgender inmates access hormone treatment after they are released.

Twenty states attorney generals (PA's AG Josh Shapiro was NOT one of them!) filed a lawsuit challenging the **Biden Administration's "guidance"** which would force schools to allow "transgender females" (biological males) to play on

girls' sports teams, shower with them, use the girls' bathroom, etc. A federal judge blocked the guidance in those 20 states.

He said he was a woman. Following **NJ's 2021 policy**, they put him in a women's prison. After he impregnated two female inmates, authorities decided to transfer him to a men's prison

**Southwest Airlines** fired Charlene Carter in 2017 because she spoke out against the union spending members' dues on pro-abortion activities. She sued and just won a \$5.1 million settlement.

A mom is challenging **Oregon's Menstrual Dignity Act of 2021** which requires schools to provide free tampons in all bathrooms, including men's, calling it a waste of funds.
