News from Around PA

The **Advancement Project**, a D.C.-based group focused on racial justice, as well as 412 Justice, a Pittsburgh-based group promoting “economic, environmental, and education justice” through the “redistribution of wealth, power, and resources” have filed a complaint with the PA Human Relations Commission against the Pittsburgh Public Schools because it is closing an “African-Centered” school. Actually, the school board has voted to close nine schools because although the district’s buildings were designed to hold 40,000 students, only 18,00 are currently enrolled.

The **ACLU-PA** and Patterson Belknap Webb & Tyler LLP filed a lawsuit against Penn State Health, Penn State Health St. Joseph, and the Pennsylvania State University after Penn State Health St. Joseph canceled a “gender-affirming procedure”.

Republican Rep. Lauren Boebert of Colorado introduced an amendment to

a bill that would have codified President Trump’s executive order banning “transgenders” from the military. It failed when four GOP joined the Democrats. One of those was Brian Fitzpatrick, (PA 1).

News from National Scene

A July report from the **White House Domestic Policy Council** concluded that the National Museum of American History “cannot be trusted to tell America’s story honestly and in a way that is inspiring, unifying, and worthy of our great republic.” This was followed by the disastrous testimony of Smithsonian National Museum of American History Director Anthea Hartig before the Subcommittee on Delivering on Government Efficiency. Now President Donald Trump is directing federal agencies to place warning signs outside the Smithsonian’s National Museum of American History, arguing that visitors deserve to know the museum’s exhibits present a politically slanted version of the nation’s past.

Footage from inside Kansas City, **Kansas Public Schools**, showing school officials discussing strategies for

secretly hiding students’ gender changes from parents. Assistant Attorney General Harmeet Dhillon issued a letter to Kansas City, Kansas, Public Schools demanding they CEASE all enforcement of their secret “Transgender Guidelines.”
