News From Around PA
LGBTQIA+ History exhibits - **419 Artifacts and The Long Road to LGBT Equality in PA** - will be on display at the Blasco Public Library in Erie throughout August.

Devereux Advanced Behavioral Health, a national healthcare with a center in Villanova, has adopted the Gender Affirmative Model, which “establishes a framework for helping children live as their authentic gender.” It addresses “the differences in supporting youth in exploring gender-expansive expressions versus affirming a gender identity.”

Reading’s Democratic mayor is refusing to allow the **LGBT “pride flag”** to be raised at City Hall because he, rightly, views it as a political symbol.

Philly’s **“Trans Wellness Conference”** will also include

a spirituality track led by Transfaith. “The conference sessions vary from a Shabbat dinner to the Muslim prayer Jumu’ah, spiritual practices in the Latinx community to a seminar on mindfulness.”

York Equality Fest will be held in Penn Park August 3 and 4. It will include an “interfaith blessing service.” It is sponsored in partnership with Bradbury-Sullivan LGBT Community Center initiative.

Central PA Pride Festival will be held today at the Soldiers and Sailors Mall on the grounds of the State Capitol.
