A National Constitution event has set a world record!! A **Drag Queen Story Hour**, hosted by the Philly Gay News and sponsored by Visit Philadelphia, had 263 in attendance setting a new Guinness book of world records! One of the organizers compared this new “history-making moment” to other real historical moments related to America’s founding in that city.

One of the first things Governor Shapiro did when he took office was to reestablish the **Governor’s Advisory Commission on LGBTQ Affairs**. Ashleigh Strange of Allentown was recently named executive director. “Their past roles include Board Chair on the PA Stands Up Institute board and Vice-Chair of the Planned Parenthood Pennsylvania Advocates Board.”

Senator Bob Casey, Jr. has announced **he has secured about \$400,000** (our tax dollars!) in community project funding for the

Philadelphia LGBTQ Mazzoni Center.

In December 2004 **Beth Stroud** was defrocked by the United Methodist Church for being a practicing lesbian, which until recently was against the Book of Discipline. She has now been reinstated!

From National Scene

Since 1869 Ocean Grove, NJ has kept its mile-long beach **closed until noon on Sunday** in order for church goers to be able to attend without having to contend with traffic from beach goers. However, the NJ Dept. of Environmental Protection has ordered Ocean Grove Camp Meeting Association, the owners of the strip of beach, to open the beach on Sunday morning. The order is being challenged.

The **Huntington Beach Longboard Pro** announced surfers must compete based on their biological sex. The California Coastal Commission objected and threatened to cancel the tournament unless the rules were changed!

The 4th Circuit Court of Appeals said the parents did

not have standing because their children were not considering “gender transition”. Now the **US Supreme Court** will not hear the case of those Montgomery County, MD parents challenging their school district’s policy of not informing parents if their child decides to “transition” if the parents are deemed “unsupportive.”

A **biological male** crushed the girls’ 400-meter record in the Washington State track and field championships.

A Los Angeles policy bans renting any city-owned facility for **“religious worship,”** while allowing many other uses, in violation of the First Amendment.
