**Montgomery County's Human Relations**

**Commission** (HRC) was established last September and the eight members were appointed in early 2026. It has now opened up its complaint process. It is the first non-home rule county in PA to create its own HRC. Montco's non-discrimination ordinance includes "sexual orientation and gender identity" – so beware Christian business owners!

**Mt Airy, described by some as one of the queerest neighborhoods in Philadelphia,** will hold its first "pride festival" on June 14<sup>th</sup>. It is being promoted as "family-friendly" with lawn games, and various free activities for all ages. However, it is not!

**News from National Scene**  
An angry father has filed a Title IX complaint against the **Old Rochester Regional School District** in Massachusetts claiming a "transgender girl" (biological male) has harassed his daughter in the girls' bathroom. Other parents have complained to the school about this same "transgender" student.

**Community Allies of Rainbow Youth**, an LGBTQIA+ advocacy organization in Ellicott City, Maryland, has introduced the "Rainbow Ribbon Schools" certification within the Howard County Public School System.

Requirements to receive the certificate include using curriculum that promotes gender ideology, promote LGBTQAI+ clubs on campus and at least 5% of media purchases for the school year include an LGBTQ theme.

**New York Democrats** have approved legislation that would strip the words "mother" and "father" from state law and replace them with "gestating parent" and "non-gestating parent."

**A lawsuit has been filed** against Washington Office of Superintendent of Public Instruction, Puyallup School District, WA Interscholastic Activities Association, WA Superintendent of Public Instruction and several school staffers, claiming that their daughter was sexually assaulted by a transgender girl (biological male) in a girls' wrestling match.
