Philly City Council adopted three resolutions proposed by the first openly LGBTQ+ person to be elected to Philly Council, Rue Landau: recognizing June as "LGBTQ+ Pride Month", declares the city's commitment to protect the rights and equal protections of all LGBTQ+ Philadelphians and the third authorizes the Committee on Legislative Oversight to hold comprehensive hearings to "examine disparities experienced by the LGBTQ+ community and explore solutions for achieving equity for LGBTQ+ Philadelphians."

National Scene From U.S. District Judge Terry A. Doughty has issued а preliminary injunction against the Title IX rule changes in Louisiana, Mississippi, Montana and Idaho. He called the change an "invasion of state sovereignty" and the demand to use "preferred pronouns" against the First Amendment.

Madonna Chism Pinkard used to work for **WFMJ TV** (Youngstown, OH) as their Community Relations Director until she posted on a company-linked social media site: "Celebrate Straight Pride," and "It's Natural, It Has Worked for Thousands of Years. And You Can Make Babies!"

A federal judge in Texas halted Title IX changes ruling the federal government "engaged in unlawful agency action taken in excess of their authority, all while failing to adhere to the appropriate notice and comments requirements when doing so." U.S. District Court Judge Robert Hinkle, a Bill Clinton nominee, permanently blocked a Florida law banning so-called "gender affirming care" for minors.

Jeffrey Little had been a member of the Los Angeles **County Fire Department** for more than 22 years. The LA Board of Supervisors passed a resolution requiring all county-operated facilities to fly the pride flag. Little requested а religious exemption from having to personally raise the flag. His request was granted, but two days later it was rescinded and he was ordered to raise the flag. The chief told him, "You are an LA County employee, that's the only thing that matters," and "Your religious beliefs do not matter."
