News From Around PA

Allentown's Bradbury-Sullivan LGBT Community Center has joined other LGBTQ groups in suing the Trump administration for correctly interpreting the word 'sex' in the anti-discrimination clause in Obamacare! The Obama administration had redefined 'sex' to include those who identify as LGBTQ - meaning hormones and sex change surgery would be covered under Obamacare.

Philadelphia-area LGBTQ

leaders recently held a press call discussing President Trump's "continual attempts to sabotage LGBTQ rights." The group included Democratic Party LGBTQ Caucus Chair Sean Meloy, PA State Representative Brian Sims, Erie City School Board Vice President Tyler Titus, community health organizer and trans activist Deja Lynn Alvarez, LGBTQ business and

political advocate Jonathan Lovitz, and Anne Wakabayashi, chair of the PA Comm. on LGBTQ Affairs.

Scott Township (Allegheny County)

News From National Scene

A yearlong investigation by the **US Department of Education** has unearth \$1 billion in anonymous foreign funding on campuses nationwide. In fact, one school had direct contracts with the Chinese Communist Party!
