**News from Around PA**

**Downingtown** (Chester County) Mayor Erica Deuso (a biological male) is PA's first openly transgender mayor.

The sixth annual **Bucks-Mont Pride Celebration** will be held June 28 at Abington Art Center in Jenkintown (Montgomery County). It is being promoted as a free family-friendly event even though it will feature a performance by "RuPaul's Drag Race" season 18 contestant drag queen Mandy Mango.

**Erie County Council President Dr. Tyler Titus** is a female who identifies as male. There was an uproar earlier this month when Councilmember Ed Brzezinski misgendered Titus, who uses they/them pronouns. Some residents have called for Brzezinski's resignation others viewed it as a "breakdown in professional conduct". Titus is a licensed counselor!

**Monroeville Ward 4 Councilman Bill Krut** shared a photo of the Monroeville

Public Library's children's Pride Month book display criticizing the collection and describing it as "child, sexual grooming." Needless to say, the next library board meeting was packed with those defending the display and criticizing Krut!.

#### **News from National Scene**

United Methodist Church has removed **Asbury Theological Seminary** from its list of approved seminaries over disagreements about same-sex marriage and LGBT clergy, after an 80 year relationship.

**Texas State Board of Education** voted 9-5-1 to approve a required reading list, which includes several Bible passages alongside works from major authors such as E.B. White, Shel Silverstein, Aesop, Kurt Vonnegut and Holocaust survivor Elie Wiesel. Fifth graders will read sections from the Book of Exodus, while seventh graders will be assigned Psalm 23.

The **U.S. Department of Education's Office for Civil Rights** launched a Title IX investigation into the Maryland State Department of Education and school districts in Montgomery,

Prince George's and Frederick counties. The investigation surrounds high school sports and policies involving boys in girls' sports.

The **Dominican sisters of Rosary Hill Home** care for terminally ill patients. New York is ordering the nuns to put men claiming to be women in women's rooms. They are also ordering nuns to call these men by female names and pronouns. The US Department of Justice is defending the nuns.

**Cleveland Clinic Foundation** in Ohio, as part of a settlement with the Department of Justice, confirmed it will not provide pediatric transgender procedures for two decades in its six medical centers and instead dedicate \$2 million to reverse or mitigate the effects of those procedures.
