News From Around PA

Over **100 Erie businesses** displayed “gay pride” flags during June-gay pride month.

Philly’s Law Dept. diversity officer wants to add more LGBT attorneys to a dept. that already has 220 attorneys.

The **Becket Fund** is expected to file the cert petition asking the US Supreme Court to review the decision of the 3rd Circuit Court of Appeals in the case involving Catholic Social Services (CSS) and the ruling that found CSS had violated Philly’s Fair Practices by not placing children in same-sex households.

Israel’s first homosexual mayor visited the **Rodeph Shalom congregation** in North Philly recently. He spoke about LGBT issues in Israel and his fight to get “LGBTQ protections” passed in that country.

Drag Queen Story Hours at the Carnegie Library of Pittsburgh and the Children’s Museum were cancelled! Andy Warhol Museum DQSH went on as scheduled.

News From National Scene

June 26th marked the fourth anniversary of the US Supreme Court’s decision in **Obergefell v. Hodges** which legalized same-sex “marriage” in all 50 states. In this decision, the Court ignored their own words of their 2013 DOMA case when they decided marriage was an issue for the states, not the federal government. Two years later, it was the exact opposite! On Wednesday, a rally was held on the steps of the Supreme Court Building demanding a repeal of Obergefell.

San Francisco school board voted to remove the “offensive” mural entitled **“Life of Washington”** at the George Washington High School in order to “right a wrong.” Critics are especially offended by panels depicting Washington among slaves at Mount Vernon and him directing white men with guns westward! They want the mural painted over with white paint in order not to

subject students to the “offensive images.”

A Baptist pastor was arrested and jailed in **Spokane, WA** simply for trying to enter the city’s public library to observe a Drag Queen Story Hour. The heavy police presence included snipers on nearby rooftops!

St. Louis Park, MN city council voted unanimously to not begin their meetings by reciting the **Pledge of Allegiance**. They argue the pledge is offensive to some in their diverse community and they want to be welcoming to all. By the way, their representative in Congress is Rep. Ilhan Omar!
