Recent documents reveal that PA's former Secretary of Health, **Dr. "Rachel" Levine** pressured the World Professional Association for Transgender Health—a transgender activist group—to drop age limits for so-called gender affirming care.

Carnegie Mellon University in Pittsburgh promoted its hosting of an intersectional keynote lecture from "one of the first African American, queer, female rabbis." Rabbi Sandra Lawson presentation was titled: "Black, Jewish & Queer: Building Bridges Across Identities & Communities."

HB 2446 and HB 2447 have been introduced in the State House by **Rep Joshua Siegel** (D-Lehigh). The bills would "protect gender affirming health care from out-of-state investigations."

A **homosexual man from Burlington, VT** has been charged with a felony and two misdemeanors for glueing his hand to a railing in

the Senate Gallery in the state Capitol Building. He was protesting GOP senators' "anti-LGBTQ legislation".

From National Scene

The Supreme Court of Texas ruled in favor of Dianne Hensley, a justice of the peace in Waco reprimanded for **not performing same-sex weddings**, reinstating her lawsuit against the State Commission on Judicial Conduct, which had previously issued a public warning for her refusal to officiate same-sex weddings, citing a violation of judicial impartiality based on sexual orientation. In 2015, Hensley had "invested extensive time and resources to compile a referral list of alternative, local wedding officiants."

Just a few short weeks ago it was revealed that the **Tractor Supply Company** had gone woke with Diversity, Equity and Inclusion (DEI) goals, carbon emissions goals, sponsoring drag queen story hours, reporting to the nation's largest LGBTQAI+ lobby group the Human

Rights Campaign for their Corporate Equality Index. They received such negative pushback, that they have issued a statement saying, "Going forward, we will ensure our activities and giving tie directly to our business." They say they will scrap the wokeness!

On the first day of "Pride Month", **Miss Maryland USA** crowned a man as the winner of the beauty pageant! He will now go on to compete for the title of Miss USA in Los Angeles in August.

The US Dept. of Interior recently released its "**Inclusive Language Guide**". It avoids gendered terms like "husband," "son," and "daughter," and even instructs its employees to use the "they/them" pronouns for individuals rather than assume someone's gender.
