**Hilltop Baptist Church in Indiana, PA** is erecting a 108-foot cross on its property. The pastor says the church is building the cross "to share the hope of Jesus Christ and to remind folks" that "God loves us." They are hoping to be finished by Father's Day.

**University of Pennsylvania anthropology Professor Theodore Schurr** has had a complaint leveled against him about his conduct and explanation of biology in his "Sex and Human Nature" class. The Trans/Nonbinary Committee at the LGBT Center, made the allegations about Schurr, saying said the professor erred in allowing students to hold a variety of positions on transgenderism.

**Delaware County** is holding its first ever Pride Parade on June 3 in Media and on June 10 a Pride Festival will be held in Upper Darby.

#### News From National Scene

Texas is the latest state to **ban so-called gender affirming care** for minors – puberty blockers, cross-sex hormones and surgeries. The ACLU plans to sue the state.

The Texas legislature has passed a bill that would **remove that state from the Electronic Registration Information Center** or ERIC. This was created by Democrat activist David Becker and "sold to states as a quick and easy way to update their voter rolls." In actuality, ERIC inflates voter rolls by requiring member states to contact eligible but unregistered residents to register to vote. ERIC partners with the Center for Election Innovation and Research (CEIR), another Becker-founded group. CEIR and the Center for Tech and Civic Life received tens of millions of dollars from Meta CEO Mark Zuckerberg leading

up to the 2020 election. Governor Abbott has not indicated whether he will sign the bill or not.

A TikTok video has revealed a **drag queen in Disneyland** escorting a young girl into the "Enchanted Chamber". The bearded man in a dress can be heard introducing himself, "Hello, my name is Nick. I'm one of fairy godmother's apprentices".

Parents have filed a federal lawsuit against the **Montgomery County Public Schools in Maryland**. Back in March the board approved 22 "LGBTQ+ inclusive texts" for grades pre-K through 8<sup>th</sup>. Parents were informed that beginning next school year "no notice will be given and no opt-outs tolerated because their kids must learn to be more 'LGBTQ-Inclusive.'"
