The court's ruling that upholds "the right" of transgender students to use facilities consistent with their gender identities in the Boyertown Area School District will be appealed.

US Senator Bob Casey, Jr. has already stated, in regards to President Trump's yet unnamed US Supreme Court nominee, "If an individual from the list provided to candidate Donald Trump by far-right organizations like the Heritage Foundation and the Federalist Society is nominated, then I am highly unlikely to support that nominee."

The Hollywood Reporter broke the news that the movie "Gosnell: The Trial of America's Biggest Serial Killer" will open in as many as 750 theaters in October.

HB 2050 passed in the Senate Judiciary Committee along a party line vote on June 13. Senate leadership needs to move this bill forward! It's already passed in the State House.

US District Judge Richard Young, a Clinton-appointed, pro-homosexual judge, issued a temporary injunction against an Indiana law that would have required abortionists to report information on medical complications.
