**Good Bill: HR 252** "Declaring June 2025 as Life Month";  
**Bad Bills: SB 819** "Protecting Trans Kids and Their Parents";  
**HB 1652** - a bill to repeal Title 18, Section 7104 which outlaws fortune telling.

Allentown has scrapped their discrimination ordinance! However, **LGBTQ activist Liz Bradbury** crafted their new one. It defines almost two dozen more terms than did the previous ordinance, including citizenship status, gender expression and genetic information. It also grants Allentown's Human Relations Commission the authority to enforce it.

**Newtown Borough** (Bucks County) will raise the Pride flag at the borough hall today.

**Penn Medicine**, the University of Pennsylvania's college of medicine that runs several hospitals and medical centers, joins Penn State Health and UPMC in announcing an end to so-called gender affirming care. However, the school clarified the change "pertains

specifically to gender-affirming surgical procedures."

**Hollidaysburg Borough (Blair County)** is being sued by the owner of a traveling adult cabaret show called Bodies in Motion. He is saying the borough's sexually oriented business zoning ordinance, which shut down his "show", is unconstitutional. The ordinance limits adult businesses to specific areas.

#### News from National Scene

Secretary of Defense Pete Hegseth has ordered the renaming of the Navy oiler "**Harvey Milk**". Milk was a 'gay' activist and known pedophile who served in the Navy illegally in the 50's. The vessel named during Obama's last administration.

A symposium at the American Psychological Association's **2025 Convention** is titled "The Kink and Flourishing Study: Impact of Kink Involvement in People's Personal Growth and Healing." And we trust these people with our nation's mental health???
